Both Solicitors and Suppliers can view lists of funders, insurers, medical agencies and expert witnesses ranging from accident reconstruction to forensic accountants.

Other tools for solicitors include a company insurer search, funder and insurer search, expert witness search and a lawyers forum where solicitors can exchange advice and swap views.

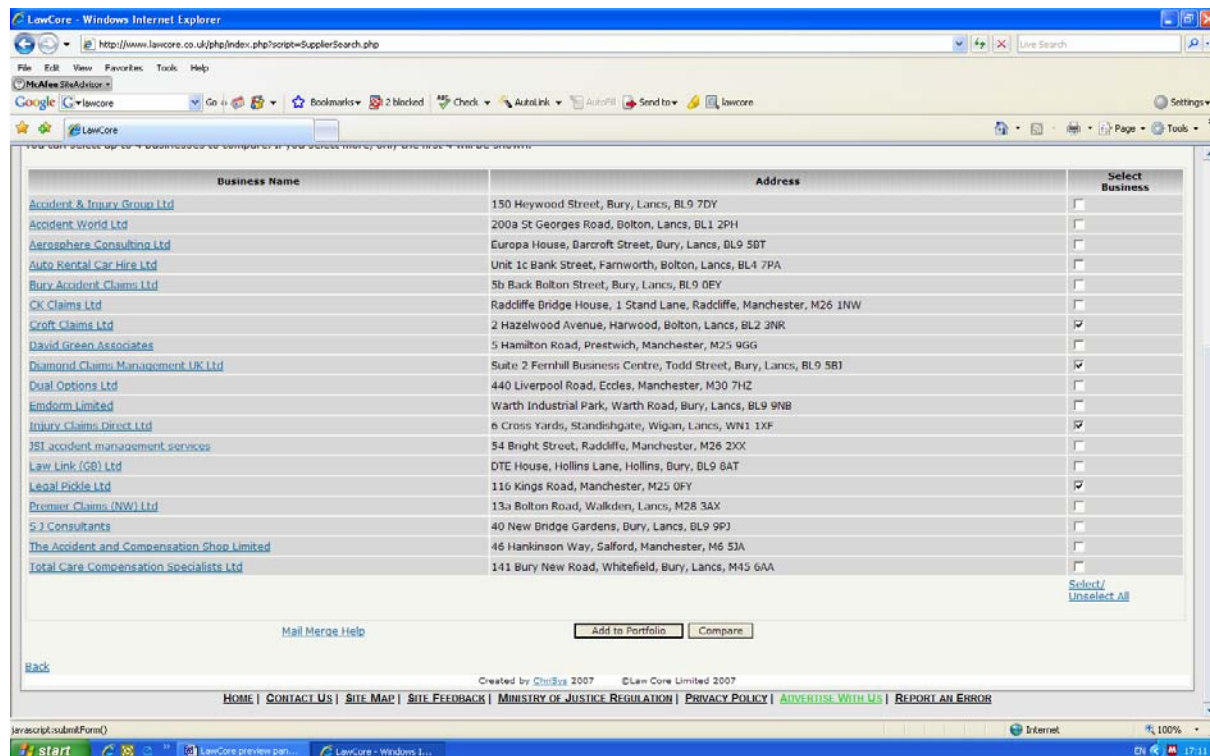
Illustrated below is a typical search that you would be able to conduct as a solicitor if you were to be a fully registered member.

The screen snapshot below shows a search for a Claims Management Company that provides CICA cases in a within a 10 mile radius of a specific postcode.



The software will also enable you to select specific Claims Management Companies and you can select companies that you may wish to add to your portfolio to enable you to make a comparison of several Claims Management Companies who provide a specific type of claim.



By clicking on the comparison button a new screen will show how the Claims Management Company accesses claims, the type of claim and their respective prices and then whether or not their claims are tied into ATE products or linked to any funders.

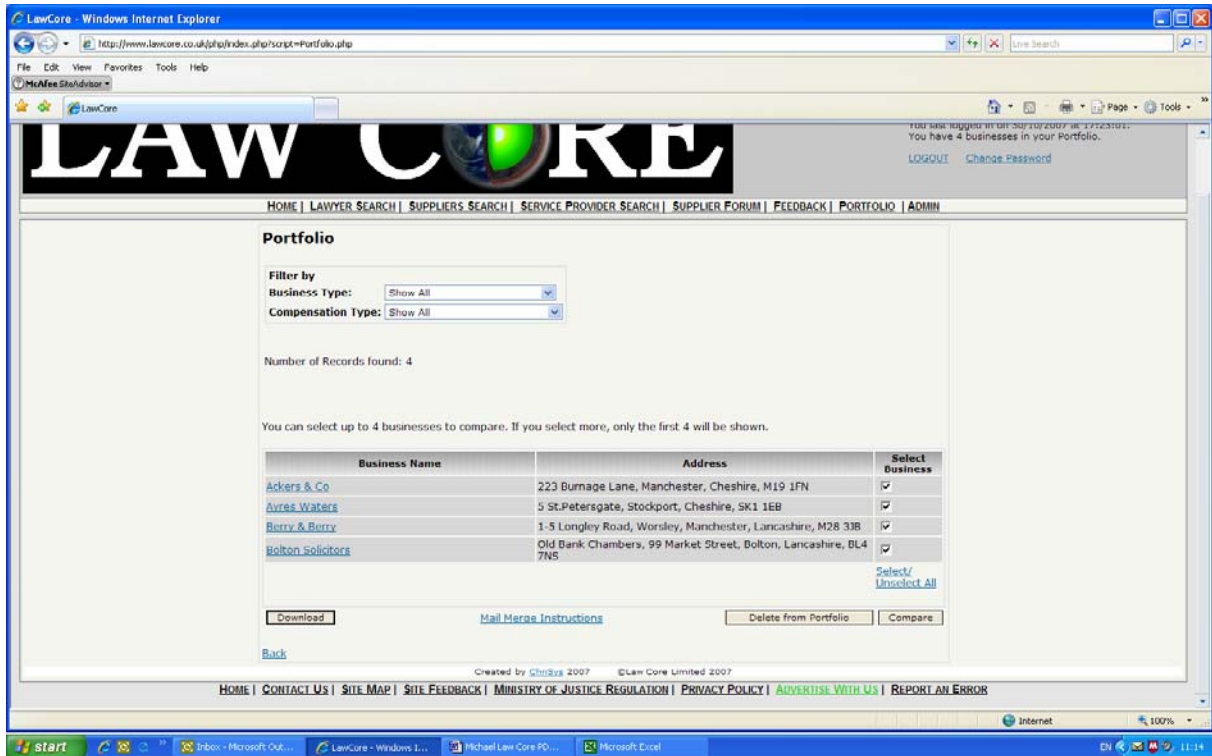
The software will also enable you to select specific Solicitors and from here you can add them to your portfolio by selection the solicitors and then clicking the add to portfolio button.

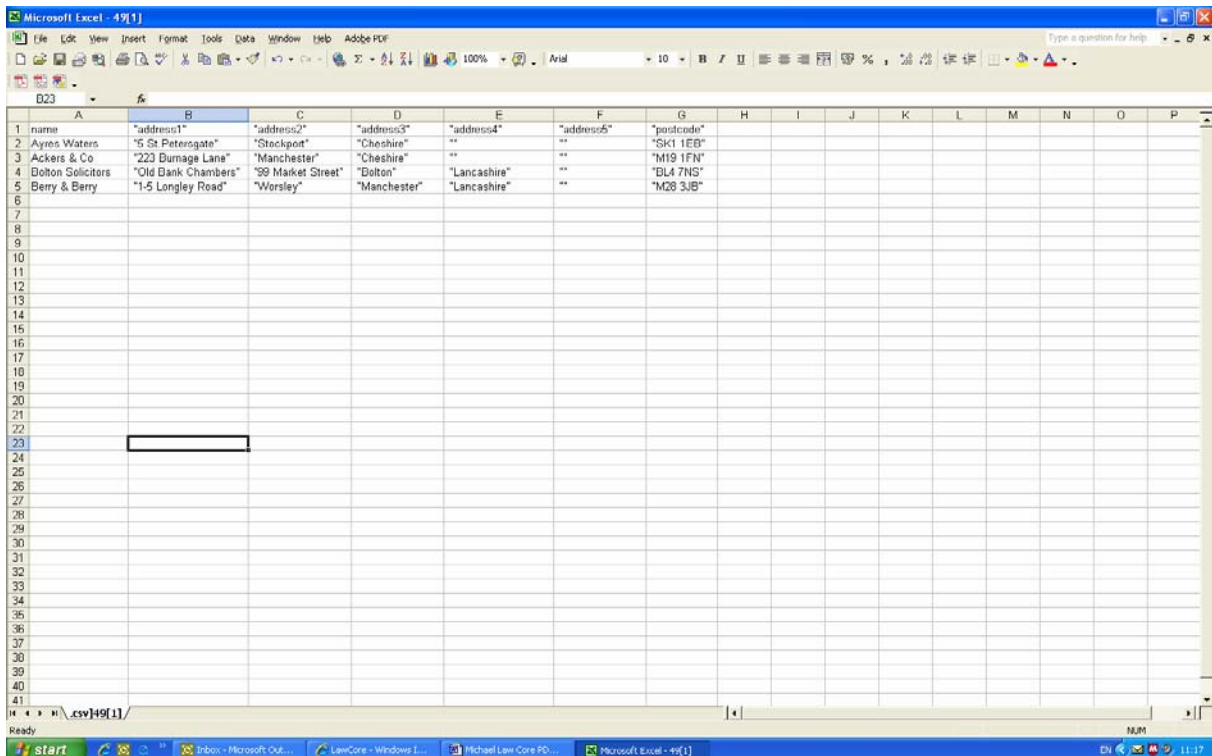
